European Commission President Ursula von der Leyen is part of a criminal organization which has attempted, and continues to attempt, the first degree homicide against a reporter for exposing her role in a scheme to defraud European tax payers of billions of euros in relation to covid vaccines.

In the course of this business, she worked with the very Billionaire sBill Gates and George Soros who was in the EC records, which she had an obligation to review, as the brains behind a criminal plot in Greece to imprison and murder a reporter, myself, in 2015 and cover up these attempts to repeat them as part of a gigantic marketing campaign of false and misleading claims to increase sales of defective jabs and a special class of epidemic vaccines to which covid, Ebola, swine flu belong.

To emphasize, her collaborators were already named in a prosecutor probe opened in Greece in 2015, which was referenced by ECP Jean Claude Juncker in a letter to me in December 2015. The

violations to cover up their crimes to repeat them are referenced in an email to me by top EC Health Officials Michael Hubel in March 2016.

Crimes motivated by a desire to silence reporter uncovering her role in a fraud and a public health scandal have serious consequences not just for me but for society as a whole and merit the heaviest penalties.

I fulfil the criteria for a science reporter also because of my reports for mainstream media including Nature, the British Medical Journal, the Scientist, The Guardian, American Prospect and other publications as a search of my name on Google Scholar shows.

As part of this business, vd Leyen misused and continues to misuse her office as ECP to help those billionaires and collaborators in pharmaceutical companies to carry out in June, July 2022 in Greece, the very same premeditated, determined murder attempt in 2015 which had been thwarted.

Because vd Leyen and her collaborators in the EU and Greek government pose an immediate threat to my life, it justifies removing any immunity they may enjoy.

I ask for their immediate arrest to protect my life, and the freedom of the media specifically.

This as a first step to a wider investigation into crimes related to the covid vaccine and contracts. When Ursula von der Leyen lures, coerces the European public to take a defective vaccine using false claims, people get sick and die.

Because of the influence of pharmaceutical companies and the Bill and Melinda Gates Foundation on the mainstream media, I was compelled to publish facts, and evidence showing the risks of the swine flu vaccine in 2009 on the social media.

That my reports continued and still continue constitute standard journalism is recognized by Jean Claude Juncker, who offered support for my fight for justice as a reporter targeted by Bill Gates and George Soros for murder.

From the inception, von der Leyen saw the reporter, myself, as a risk. She knew she was engaging in an aggressive campaign of false and deceptive marketing and did not want it exposed.

Violating EC rules, she has deliberately concealed her financial conflicts of interest to hide the influence industry has exerted on her decisions. She has knowingly been orchestrating a massive fraud, diverting billions of euros of European tax payers money to mRNA covid vaccines, which she knew or should have known to be unnecessary, defective and harmful from the debate inside the EC records. This, for her own personal benefit. and to help grow her husband s mRNA company, Orgenesis, as well as generate a windfall for her collaborators in pharmaceutical companies,

especially Pfizer, in PR company McKinsey, the former company of her son, David, as well as her Billionaire collaborators Bill Gates and George Soros. Showing reckless disregard for the mounting evidence of the damage to the public health, her policies have been motivated by greed.

She did not want any of this information to reach the public. To ensure that it did not, she was ready to resort to any crime together with her collaborators in a premeditated, determined murder attempts against reporter.

The letter of ECP Juncker shows that she knew or should have known about Greek prosecutor probes which reveal Bill Gates, George Soros and other actors in the pharmaceutical companies and media not to be philanthropists trying to save human lives but unethical, callous actors driven by the search for profit.

In fact, she approved and sanctioned the repeat of the exact identical crime which had triggered the probe in 2015 the first place. That is why those directly responsible are so clear. That is why the element of premeditation, deliberation is so clearly proven.

This is why the proofs against Gates and Soros are now strong enough to prosecute them for first degree attempted murder along with their collaborator vd Leyen and order their immediate arrest.

The legal proofs are water tight.

Before describing the attempted murder plot, I will discuss first the motive for it. What was she so desperate to hide? What information which I was exposing largely on my fourthempire blogspot but also in emails did she fear so much? When we consider this question, it is important to recognize she is acting as part of a criminal cartel who have a common cause in silencing a reporter exposing their false and deceptive covid vaccine marketing campaign, and that she works as part of a

network. Without vd Leyen in the office of ECP, it would be impossible for this network to carry out its improper marketing campaign and act with impunity, corrupt justice officials and commit first premeditated murder attempts against a science reporter as I show.

## PART 1 THE MOTIVE FOR URSULA VON DER LEYEN S MURDER ATTEMPT

### Conclearing crruption and conflicts of interest

From the day she applied for office of ECP in July 2019 through to today, December 2022, Ursula von der Leyen has been engaged in a scheme to defraud European tax payers of billions.

When we look at the EC records and information in the possession of ECP vd Leyen when she assumed office end 2019 and was confronted with the covid emergency, we can have no doubt, she knew or should have known all about the swine flu vaccine scandal which resulted in an inquiry in 2010 by the Council of Europe PACE. This criticised unjustified scares and fears, the influence of pharmaceutical companies and a lack of transparency and accountability.

As ECP von der Leyen is obliged to follow a code of conduct which includes declaring conflicts of interest and reviewing EC records on policies, exercising the precautionary principle and being independent of all outside influence. The aim of these codes is to ensure the ECP acts in the interest of the EU.

From the beginning, Vd Leyen has sought to evade rules and statutes designed to protect the public from corruption. She knew that she was violating EC rules on conflicts of interest and independence when she failed to declare the financial conflict of interest of her husband s company, Orgenesis, a developer of the mRNA technology. But she was determined to advance a scheme to make money for her self and her family members and partners and so hid the fact that her decisions were tainted. Tellingly, her office did not respond to my email requesting a copy on 28<sup>th</sup> November 2022

She knew that filling out the form correctly would draw attention to a conflict of interest and raise the question of the role of the profit motive behind her decisions, and even trigger an inquiry as in 2010 over pharma's hidden influence over key decision makers behind the swine flu vaccine roll out.

That is why in her public declaration posted on the EC website, she falsely denies any financial conflicts of interests. By filling in as answer to the questions about potential conflicts of interest of her spouse, with "non applicable", she downplayed and hid the influence and control exercised over her by her husband's company Orgenesis and mRNA vaccine manufacturers.

The combined purpose and effect of these statements and declarations is to paint a picture for the European consumer that von der Leyen is an independent public servant who is acting only for the benefit of consumers.

She repeatedly implied her only motive was to protect people when she knew that she and her family were growing richer and richer from her policies. But she was determined to ensure the public never heard about her scheme by joining in a plan to murder a reporter, myself, with her collaborators.

### Concealing her corruption in dealings with Orgenesis, the company of her husband Heiko von der Leyen

Ursula von der Leyen said that the mRNA covid vaccines were about protecting the European public from a covid epidemic. But they were really chosen because her husband's company, Orgenesis Inc. Biotechnology Research. Maryland, was developing this new technology, stood to make a fortune from her policy decisions.

Heiko von der Leyen, a doctor and scientific director of the US biotech company Orgenesis, which specialises in cell and gene therapies and is a frontrunner in the development of RNA COVID vaccines.

The cash tills in her husband's company Orgenesis ran when she focused on the mRNA technology he researched as the injection the EU would use to combat covid and changed a GMO directive to ensure these new gene editing technologies could be used with the help of the European Parliament, including Greek MEP Eva Kaili. . Kaili is the first woman Chair of Science and Technology STOA Panel 2017-2022 and the Center for Artificial Intelligence.

Heiko von der Leyen was involved in a foundation established by the University of Padua on 8 June 2022 to manage research into RNA gene therapy and pharmaceuticals. This project is being financed under Italy's National Recovery and Resilience Plan through the EUR 320 million paid to the Italian Ministry of Universities. It involves University of Padua and 49 other entities bodies, including universities of Siena, Modena, Rome and Milan, the Italian Institute of Technology, the Bambin Gesù Hospital in Rome and three private-sector companies.

Von der Leyen represented Orgogenesis, which is one of the project founders and will receive EUR 200 000 in contributions each year.

He resigned from the board of 'National Centre for Research and Development of gene therapy and pharmaceuticals using RNA technology' based in Padua on 27<sup>th</sup> October 2022 after media began to report on the conflicts of interest.

Vd Leyen changed the EU rules on GMOs to allow mRNA s to be used to benefit the technology her husband specialize in and give grants and contracts

To be able to use mRNA covid vaccines at all, the EU s GMO directive had to be changed.

And vd Leyen changed it in June 2020 so removing an obstacle to his entry to a lucrative market she had created for mRNA vaccines, to which she would allocate 71 billion euros by the end of 2021.

Injecting a GMO technology into some one should require the most stringent checks. They are recognized as being potentially toxic to the environment and humans.

But von der Leyen and her collaborators in the EU Parliament made sure these stringent checks were dispensed with.

In June 2020, ECP von der Leyen proposed changing the EU's rules on GMO in order to allow clinical trials for covid vaccines with GMO, namely the nano lipid element used mRNA vaccines.

She issued Regulation 2020/1043 - Conduct of clinical trials with and supply of medicinal products for human use containing or consisting of genetically modified organisms intended to treat or prevent coronavirus disease (COVID-19)

Her proposal was adopted in July 2020 by the EU Parliament clearing an obstacle for the use of mRNA jabs in the EU, to the multi billion euro mRNA covid vaccine deals, and so profiting companies focused on mRNA research such as Heiko von der Leyen's Orgenesis

In December 2022, Eva Kaili and her father Alexandros from Thessaloniki as well as her partner were arrested for accepting 100s of thousands of euros of cash from Qatar in return for political favours.

In 2020 Kaili welcomed the plan of von der Leyen to change GMO rules to allow a GMO to be used in the covid vaccines and sanctioned and approved a glowing report about the nano lipid particles to be used to transport the messenger RNA into cells.

The enormous influence of Kaili in the European Parliament and her support ensured that von der Leyen's plan became law despite the obvious dangers of allowing a completely unknown GMO and a gene editing technology to be injected into the blood streams of hundreds of millions people, including children.

Member States adopted the decision pursuant to Article 5(1) and (2) of Directive 2001/83/EC or Article 83(1) of Regulation (EC) No 726/2004 concerning medicinal products containing or consisting of GMOs intended to treat or prevent COVID-19, an environmental risk assessment and/or consent in accordance with Directive 2001/18/EC or Directive 2009/41/EC are not a prerequisite.

Vd Leyen hollowed out the ethical and scientific safeguards intended to guarantee the safety of mRNA vaccines under development. In order to increase sales and profits.

These vaccines containing genetically modified organisms (GMOs), would not have to provide an environmental impact assessment for the clinical trials phase and compassionate use.

GMO vaccines include nucleic acid vaccines (containing DNA and mRNA) and non-multiplicative viral vector vaccines which have never been approved for use in humans and are still experimental.

She knew that the real effects on health are not properly understood. She knew she was obliged to observe reactions following the administration of a vaccine.

Her statements and omissions painted a picture for European consumers that there was a minimal risk from the mRNA vaccines, that there were safe, effective and the key to ending the epidemic.

She said the mRNA vaccines would be authorized on the basis of 'less comprehensive data than would normally be the case' but these few admissions were not emphasized in promotional material.

Her statements are false, deceptive and misleading.

While Orgenesis and her husband have made significant sums from the mRNA, vd Leyen deceives and misleads the public about the risks of this new technology.

This is a genetic injection, a completely new technology.

The mRNA are based on genetically modified organisms and use nano lipids never used before.

There is no evidence of their quality, safety and efficacy. The use of genetically modified organisms to treat or prevent coronavirus disease, a virus with the death rate of the seasonal flu, is one of the most reckless, dangerous public health decisions in the history of Europe.

China rejected the use of these mRNA vaccines over safety concerns.

The GMO element of these vaccines has been linked to the soaring number of deaths and injuries, also from clots.

Shares in manufacturers of mRNA vaccines Pfizer and Moderna soared to record heights as ECP vdLeyen oversaw the signing of 71 billion euros of covid vaccine contracts for 4,6 billion euros. Revenues and profits also reached new records. Pfizer CEO Albert Bourla became one of the best paid CEOs in the USA with a reported salary of 24.3 million in 2021 a 15% increase over the previous year.

And Orgenesis profited with the manufacturers as a player in the mRNA segment.

It was only when media began to report on the von der Leyens conflicts of interest that Heiko vd Leyen resigned from a mRNA research consortium funded by the EC. His company had received 383,000 euros directly from the EC.

A chronology of von der Leyen s actions to profit Orgenesis and collaborators in phrmaceutical corporations

As soon as she entered office, she pursued aggressive sales strategies to increase the sales of the experimental vaccines, licensing Ebola s Merck vaccine.

This, although she had in her possession very specific warnings about this special class of vaccines to which swine flu, bird flu, Ebola and covid.

To get authorization, she omitted material facts in the records of the EC about Ebola and Ebola vaccine in EC records. The EC records also reveal an open discussion about epidemic disease and Ebola vaccine policies with the Chair of the Health Committee of UK Parliament in 2016 and a top EC health official in 2016.

This information which was relevant to the EC s decision making process then, and are still relevant to the EC s policy decisions in 2022, and reveal the decision of vd Leyen to spend millions promoting an Ebola trial in Uganda in December 2022 with experimental Ebola vaccines which could give people Ebola, is motivated by a desire to make profit and seize a new business opportunity for her and her collaborators disregarding the risks to public health.

Covid, Ebola were and are opportunities. She could not and can not wait to increase sales.

Already in 2019 saw a growth opportunity for the covid vaccines and increase sales. The marketing plan relied heavily on fear.

On 9<sup>th</sup> January 2020 the EC s DGS received its first covid alert on the EWRS.

Within just ten days, on 17th January 2020, the Health Security Committee held its first meeting on covid.

On January 30<sup>th</sup> when there were no deaths in Europe from covid, von der Leyen declared it a public health emergency in line with WHO s PHEIC declaration.

On 31<sup>st</sup> January, she mobilized <sup>the</sup> first funds mobilized for the covid outbreak under the Horizon programme, including for mRNA research.

She misled and continues to mislead the European public by failing to disclose her conflict of interest to them, failing to acknowledge her husband's company stands directly to profit from her decisions.

Until 2020, Orgenesis, like other developers of mRNA technology had languished on the margins of the biotech community with low revenues. But as soon as vd Leyen declared she would make mRNA jabs the centre piece of her covid response in early 2020, revenues started to soar.

Her husband's company directly benefited from her decisions. There is a direct link, cause and effect.

The Greek government under Mitsotakis was ready to give Orgenesis 32 million euros in grants in 2021. This is the very same Mitsotakis and Greek government which has played such a vital role in corrupting justice to allow von der Leyen and her collaborators to continue their crimes against the reporter. Mitsotakis and the von der Leyens have a common cause. They both have reason to fear exposure of their campaign of false and deceptive marketing.

The announcement of the government grant on November 29<sup>th</sup> 2021 sent Orgenesis shares higher, climbing 0.9% to \$5.65 in Nasdaq trading.

On 11 May 2020, Orgenesis reported its Q1 revenue increased 348% to 1.9 million.

On 13 May 2020 Orgenesis announced a mRNA or cell based vaccine platform targeting covid.

16 June 2020, von der Leyen announced the covid vaccine strategy and a focus on mRNA vaccines.

To allow these vaccines, vd Leyen had to change rules on GMOs. And she did.

15 July 2020, the EC GMO directive was changed to allow mRNA vaccines.

The EU Parliament's Science and Technology panel, chaired by Greek MEP and EU Parliament VP Eva Kaili, gave a positive opinion about the element which required the change, the nano lipids.

And with the way clear for billions of euros of tax payers money to be poured into mRNA research and vaccine, Orgenesis profits continued to soar.

On 7 May 2021 Orgenesis reported its Q1 revenue increased 400% to 9.4 million.

On 3 May Orgenesis reported its subsidiary, Biotech BV, had received grant of four million euros as part of the “European Innovation Council Pathfinder Challenge Program” controlled by the European Commission. The loan was given for the production of autologous cells in association with artificial intelligence.

Orgenesis also received 383,000 euros directly from the EC as part of a mRNA research consortium based in Padua on whose board the husband of Ursula von der Leyen sat until October 2022 when the media focussed on this clear conflict of interest.

In 2023, Orgenesis projects its revenue to be 53 million dollars, about twice as much as its combined total revenue for the five years before von der Leyen took office.

### Pfizer BioNtech s and other manufacturer s staggering revenue growth thanks to vd Leyen

The profits of Pfizer and BioNTech also leaped on the news it was a favoured candidate of von der Leyen as well as Bill Gates, whose Foundation took over a substantial stake in BioNtech in 2019.

It was von der Leyen who personally negotiated a vaccine contract for up to 1.8 billion doses with Pfizer's CEO Albert Bourla believed to start in the summer of 2020. She has refused to reveal her communications despite a request from the Ombudsman.

11 June 2020, the EIB announced 100 million for BioNtech.

The ECA describes how vd Leyen “signed an agreement with the 27 Member States, allowing it to conclude Advance Purchase Agreements (APAs) with COVID-19 vaccine manufacturers on their behalf<sup>8</sup>. APAs are contracts in which the Commission secures Member States’ right to buy a specified number of vaccine doses in a given timeframe and at a given price. In return for securing future vaccine supplies, part of the development costs faced by vaccine producers was financed by down payments from the EU budget. This ensured Pfizer and others gigantic profits by locking governments into an obligation to purchase them.

Vd Leyen's Commission signed contracts worth €71 billion for deliveries of up to 4.6 billion COVID-19 vaccine doses. Between August 2020 and November 2021, the Commission signed 11 contracts with eight vaccine manufacturers providing access to up to 4.6 billion vaccine doses (see Table 1) at an expected total cost of close to €71 billion. The weighted average cost per dose is approximately €15. This figure is calculated on the basis of doses actually ordered (delivered and yet to be delivered). Options not exercised are not included.”

On 24 August 2020, Professor John Bell, the developer of AstraZeneca a covid vaccine told Channel4 News the vaccine could be expected to sterilize only 60 to 70% of a population.

But then don't forget, these vaccines are unlikely to completely sterilise the population. They're very likely to have an effect which works in a percentage, say 60 or 70 per cent. We'll have to look quite carefully, and the regulators will have to look quite carefully, to make sure that it's done what we need it to do before it gets approved. So, there will be a delay between the outcome of the trial and a decision whether it can be approved as a vaccine.”

When his comments went viral, he attempted in vain to claim he did not mean what he said and his comments were taken out of context helped by so called fact checkers.

But his clear and public statement is no doubt one reason why AZ has never been authorized in the USA and withdrew its application altogether end 2022, despite having collected data for two year sin Europe and the UK which should have shown its efficacy.

Yet on 27<sup>th</sup> August, von der Leyen sanctioned and approved its first contract with AstraZeneca despite this clear and public statement and red flag.

On 9<sup>th</sup> September,2021 her EC announced its portfolio of mainly mRNA covid vaccines.

On 21<sup>st</sup> December2021, her EC authorized the first covid vaccine.

Armed with EMA approval and messaging and materials, ECP von der Leyen distorted the benefits and risks of the covid vaccines. She repeatedly called it safe and effective.

She omitted to mention that there was no such proof that it was safe and effective, that the EMA approval was conditional and that the experiment was starting and all the people taking it were a part of the experiment.

She understated the risks of using an entirely new mRNA technology which alters genes.

She disseminated the pharmaceutical message to the doctors in the guise of science and the truth through such tactics as underwriting scientific studies to be published as seemingly neutral articles in medical journals, paying prominent doctors to endorse products, marketing a flu like virus for which there is natural immunity as medical conditions requiring treatment and vaccines.

By end 2021, she had sealed 71 billion euros of covid vaccine contracts for 4.6 billion doses.

She funnelled EC funds into the scheme and committed EU Member state governments to spend billions. Guaranteed a fixed price, manufacturers could mark up the prices for their jobs, enjoying huge profits.

27<sup>th</sup> July 2021, it was announced 70% of the Eu population was vaccinated with one dose.

For this entire period, von der Leyen feigned and dissembled the mRNA and covid vaccines were safe and effective when she knew it was not true.

She presented Pfizer, BioNtech and collaborator s promotional material and content as if it was neutral science.

She repeatedly implied her motive was to protect people when she knew that she and her family were growing richer and richer from her policies.

To ensure the success of its strategy, ECP vd Leyen backed a plan to dangle financial incentives to doctors.

In Germany, doctors receive 28 euros for every covid vaccination, an extra 8 euros for a vaccination given at the weekend, holidays or given over Christmas period, that is 36 euros.

35 euros for a house visit including a covid vaccination, 10 euros for a vaccine consultation  
2 to 6 euros for issuing a certificate.

Doctors are required to report how many doses they administered every day using the Impf-DokuPortal der KBV and special codes.

So doctors could earn bonuses of thousands of euros a week for administering the covid vaccine depending on how many vaccines they gave.

At the same time, doctors were and are not paid to record side effects.

It is an experiment and side effects should be recorded. But there are no financial incentives given to doctors to report these or an easy method.

ECP von der Leyen and collaborators knew that enlisting doctors and giving them a financial incentive would be effective in increasing the sales and profits for the vaccines.

And she knew that conscripting doctors into a campaign to suppress the side effects by giving them financial disincentives would be effective in decreasing reports about them.

As the ECP vd Leyen was in a key position to couple basic human rights with sales of the defective product. European consumers were not to decide for themselves if they wanted to have their product. They were to be coerced.

The consumption of their product was linked to the right to work, travel, go outside, for example, in Austria where there was a lock down only for the unvaccinated in autumn 2021.

She proposed a digital passport, some kind of vaccine tracking device integrated into a identity cards for sales purposes.

Connected to some kind of network, operating system, these passports would include a record of covid vaccines.

The EU would track European consumers across the continent using these devices and de facto prevent them from leaving a country unless they had consumed their defective product and in the quantity wanted by the manufacturers, von der Leyen and collaborators.

Concealing her corruption in dealings with McKinsey, the company of her son worked for and which put her into office

Another beneficiary was McKinsey, the US consultancy company for which David vd Leyen, her son, worked until 2019, the period when McKinsey played a decisive role in placing her into office in 2019.

McKinsey when vd Leyen s son, David, worked for it was at heart of an investigation by the German parliament into vd Leyen s nepotism and lavish spending during her tenure as Defence Minister. An investigative committee of the German parliament looked at lucrative contracts from her ministry were awarded to McKinsey without proper oversight, and whether a network of informal personal connections facilitated those deals. In 2015, auditors estimated that the ministry had spent up to €100 million on external consultants, but only officially declared €2.2 million for the purpose. In 2016 later, the ministry had spent up to €150 million on advisers while declaring only €2.9 million. The main beneficiary? McKinsey and its affiliates and subsidiaries.

Analyzing 56 out of 375 contracts awarded to consultants during the years 2015 and 2016, the Federal Audit Office found that in the vast majority of cases, vd Leyen did not provide sufficient justification for using consultancies. In more than a third of the cases, and procedures did not follow the normal rules for awarding contracts.

It was a story that vd Leyen was to repeat as ECP.

And it was Macron who made a decisive intervention in 2019 and made "back room deal" with Angela Merkel to block the democratically elected candidate Manfred Weber and make von der Leyen the successor of Jean Claude Juncker .

The role of McKinsey and Macron in acting as secret lobbyists for pharmaceutical companies and Billionaires in undermining democracy in the EU cannot be overstated. McKinsey's man in Paris Macron helped by Angela Merkel usurped the elected candidate for ECP Manfred Weber, to put von der Leyen in power without revealing the real goals of McKinsey and their clients in industry to profit from a historical crisis, the covid crisis.

French police raided the offices of Macron's party, Renaissance, and the offices of McKinsey in Paris on Tuesday, 13<sup>th</sup> December 2022, as part of their investigation into the use of consultancies during Macron's presidential campaign in 2017 and 2022 and illegal campaign financing.

McKinsey has enjoyed lucrative consultancy contracts also to promote the mRNA and other covid vaccines from the French government. Macron placed McKinsey staff who worked for his campaign in positions in government.

During the covid crisis, McKinsey became the chief advisor in terms of public spending, including on the covid vaccines. Gigantic sums were spent on covid vaccines under the direction of the private US consultancy company which works for Gates and Pfizer.

In addition, Macron worked to ensure McKinsey did not have to pay taxes in France...

According to Le Monde, McKinsey oversaw the administration of the COVID-19 health pass and vaccine strategy in France.

Intransparent back room deals have also characterized von der Leyen's covid vaccine contracts with Pfizer especially, some of which she negotiated by secretive SMS and phone calls with CEO chief Bourla. Intransparency tends to correlate with corruption and bribe taking.

McKinsey worked for and may still work for Gates in transforming WHO into an instrument for rolling out experimental epidemic vaccines.

To shorten this submission I refer you to the scientific panel convened by Senator Ron Johnson on December 7<sup>th</sup> 2022 for some of the evidence, including the presentation of Dr Kirk Milhoan that mRNA vaccines turn the human cells into a factory producing a poison for the heart, the COVID-19 spike proteins, triggering an immune response.

For OpenVaers only captures deaths directly and officially linked to the covid vaccine.

Any cases of cancer, heart attack, suicide, autoimmune diseases, thrombosis which are not directly linked to the jab are not registered on OpenVars. And there may be many of these cases.

The Washington Post reported 58% of all covid deaths are now due to the covid vaccine.

Again, it is important to recall that there was not a single death from covid recorded in the USA, UK or Europe when the decision was made by ECP von der Leyen to give these jabs to Europeans after WHO's declaration of a PHEIC.

With a fatality rate of the flu, there was also no likelihood of more deaths than the flu.

Now, there are millions of excess deaths and injuries linked to the covid vaccine in the USA and Europe, though every effort has been made to hide, obscure the European data by ECP von der Leyen.

Despite the WHO declaring Ebola a public health emergency of international concern two times in 2014 and 2018, Ebola never became a threat to Europe and the risky Ebola vaccines were never rolled out under ECP Jean Claude Juncker and his team.

If there was, and is, no need for experimental Ebola vaccines to be rolled out for a disease with a high fatality rate like Ebola, then how much more unnecessary was, and is, it to roll out experimental covid vaccines for a virus which has the death rate of the seasonal flu, at just 0.096% according to PHE.

ECP von der Leyen knows or should know this special class of experimental vaccines, to which Ebola and covid belong, are dangerous. It's in the EC records. She knows or should know that there was a scandal over the swine flu vaccine campaign in 2009 which culminated in an investigation in the Council of Europe in 2010.

The investigation concluded that national governments, WHO, and EU agencies had all been guilty of actions that led to a “waste of large sums of public money, and unjustified scares and fears about the health risks faced by the European public”.

Worse, the swine flu vaccines caused narcolepsy in some of the relatively tiny number of people who took it in 2009.

If ECP vdL had performed her duty of care, then there would have been no vaccine rollout with experimental covid vaccines on the basis of a virus no worse than the flu.

But she did not fulfil her duty of care. She wilfully ignored the records, and purposefully rolled out the vaccines using a campaign of false and deceptive marketing.

She wilfully ignored the warnings in the EC records, and purposefully rolled out the vaccines using a campaign of false and deceptive marketing.

Despite this OpenVaers and Excess data from government sources, vd Leyen and the EC team routinely fails to identify these soaring excess deaths as suspicious,ask why are people dying, young people, from myocarditis.

They wilfully blind themselves to one of the most important indicators of the negative impact of their defective product and soaring deaths.

It is a legitimate question whether the data collection was and is being deliberately structured to evade scrutiny, whether the pharma companies were and are fulfilling their obligation to halt the experiment when safety signals appear, why they are allowed to go on for years without reporting anything at all despite the increasing excess deaths across all age groups since 2021.

Similarly, the EMA has made no effort to collect the data, structure it and publish it, conduct periodic checks of the progress of the experiment, investigate the patterns of excess deaths in countries around Europe and the USA, which are not related to higher temperatures as an examination of the temperatures can show.

Instead, they continue their false and deceptive marketing to promote covid vaccines as safe and effective.

## PART 2 VON DER LEYEN S PREMEDITATED MURDER ATTEMPT s

### VON DER LEYEN S PREMEDITATED MURDER ATTEMPT IN JUNE, JULY 2022

THE BASIS IN A GREEK PROBE D 15 218 OPENED IN 2015 MEANS THE PROOFS ARE WATER TIGHT.

None of her corruption and the harms linked to the mRNA vaccine could have been possible if the media is free to report on them.

Ursula von der Leyen recognized this from the moment she took office end 2019.

This Greek probe with the proofs against Gates and Soros is referenced by ECP Juncker in his letter to me in December 2015 which is in the records of the EC which von der Leyen is obliged to review.

It was not just that the investigative process got stuck.

It was corrupted altogether. It was done so by Greek government officials at the highest level. It was done so to get Gates and Soros off the hook. These are the violations referred to by EC official Michael Hubel in an email to me in 2016.

The cover up was done in a way for the culprits to be able to repeat the same crime. I warned the Supreme Court in Athens about this in my submission and appeal and emails.

But as I show, Ursula von der Leyen ignored these records deliberately in order to join a repeat of that very same crime in June, July 2022 using the same statements, network, method documented in the probe D 15 218 opened in 2015.

This crime is broadly described in an email which I sent as soon as I escaped on July 27<sup>th</sup> 2022 to alert people. Email called “JANE BURGERMEISTER IMPRISONED IN GR”

The fact that the same statements were used, the same network and the same method eight years later highlights the calculated premeditated and determined nature of Gates, Soros and their collaborator von der Leyen of their attempts to murder me for exposing their corruption and false claims.

Freedom of the media is considered a threat to her and her collaborators. No crime was and is too brutal, cruel, heinous to ensure their corruption and profiteering remain hidden.

Aware that she and her collaborators could soon be subjected to civil and criminal penalties for their role in the covid vaccine improper marketing scheme and many injuries and deaths caused by the vaccine, von der Leyen wilfully and deliberately joined in the crime thwarted in 2015. When

this crime failed, she initiated, organized and carried out other crimes misusing her office to create the high level of impunity needed to carry out deadly attacks against a reporter.

Gates, Soros and pharmaceutical companies only continue their attacks against me because they believe they can get away with it.

The installation of their ally, vd Leyen in the ECP end 2019, and using PR company McKinsey, represented a significant competitive advantage for Pfizer and other pharmaceutical companies also when it came to their crimes and censorship.

Gates and Bourla no longer had to fear a letter of support to me from the ECP like Juncker s. They knew that their crimes would go unpunished because the ECP vd Leyen, her husband, Heiko, were part of a scheme to make money from a defective product using improper marketing.

When the rule of law fails, our societies fail. When crimes are committed by our highest officials, like ECP vond er Leyen, go unpunished, it is a threat to all the people of Europe and the very future of Europe itself. When they are committed against a reporter for warning people about a defective vaccine product, then people can get sick and die.

The murder attempt in April 2015 is proven. It is proven by the evidence collected in probe that was opened by the police in Larisa, Greece with the file number D 15 218.

Precisely this original crime was repeated as I show below.

When the police and prosecutors opened a probe, the people who carried out the attack, the hitmen, the instruments, were the focus. But in the course of the probe, the masterminds behind the murder were found.

A report in The Tampa Bay Times in August 2014 provided evidence of the personal knowledge of Bill Gates, George Soros. Together with the motive and means, everything was ready for their conviction. The original murder attempt was disguised as an emergency psychiatrization. The plan was to remove me at lightning speed without me having the chance to warn others. The goal is also to misbrand an experienced science reporter as "crazy and evil" to fit their marketing plan.

All of the aggravating elements of premeditation and deliberation apply to the attempted murders against me in Greece for exercising my function as a reporter as recognized by ECP Juncker. They are premeditated, determined, relentless.

Murder and conspiracy to commit murder are just some of the serious felonies that do not have a statute of limitations. A person may face these charges even decades after they allegedly committed the offense.

So may their instruments.

An attempted murder is punished as severely as an actual murder.

A murder or attempted which is planned deliberately and carried out with premeditation carries the heaviest penalty in many US states, the death penalty.

The fact that vd Leyen, Gates , Soros and their collaborators have not succeeded in each of their many murder attempt until now is due to factors that escaped their control.

In April 2015, the local police refused to carry out the request to forcibly confine me under emergency laws because my reports showed I was mentally ill, telling the culprit a prosecutor was required to sign the order.

The culprits omitted to mention my reports were taken seriously by the Chair of the Health Committee of the UK Parliament who invited me to testify on pandemic preparedness in January 2016 as referenced in the email by Michael Hubel.

But in June 2022, a corrupt prosecutor implicated in the cover up of the original crime signed the order as von der Leyen held her protective hand over the corrupt Greek officials.

The fact that I escaped in July 2022 was outside their control.

Various factors intervened. I did get out in July 17th only to be immediately transferred to the covid ward under a fake pretext of being covid positive.

What Gates, Soros failed to do in 2015, they carried out 8 years later when the political opportunity arose with the retirement of ECP Juncker and the appointment of vd Leyen to ECP.

Throughout this period, they planned, plotted, deliberated, desired, wanted to murder me and sought every opportunity to do so.

They have shown no remorse, no repentance.

I will not describe these events here but refer you again to the emails I sent as soon as I escaped. And I had literally to make a run for it with my rucksack on my back, racing about 200 metres,

dodging obstacles to get to the exit, out of the hospital grounds and to a taxi to Thessaloniki where I found a cafe to send the emails and alerts.

So serious are the violations of due process and law which led to me being imprisoned and held in Exozee that when I escaped and was able to alert others, no attempt was made to arrest me and bring me back.

This fact alone shows that I was the victim of justice, police and doctors who had gone rogue. They knew they were committing crimes under the colour of their office which could not stand proper legal scrutiny.

It would not have been possible without the help of vd Leyen.

Political power is needed to uphold the fake narrative that this imprisonment was in accordance with the rule of law.

We can see why von der Leyen and her collaborators decided to use the very same discredited and implausible statements to carry out the same crime.

They had organized through massive violations that the culprits in 2015 had been found innocent and so myself guilty by denying me the right to appeal the verdict by changing my status from party to witness as described in the detailed summary here with links to the Greek court documents.

They had organized through massive violations the sentencing of myself to one and a half years in prison for posting up proofs of their own violations in September 2021 as referenced by the email of EC official Michael Hubel.

The same cartel thought they could repeat their failed crime and, this time, succeed and execute the perfect crime from their point of view again using the same network, same documents and disappear me, murder me in 2022.

A plan to replace me with a digital version or a double would explain the repeated focus on obtaining personal photos, certificates and originals from me.

The cartel even seized by phone, computer and papers as part of their illegal eviction plot in December 2022 where vd Leyen's role becomes more clear.

That they should choose to use the very statements which were in the prosecutor files D 15 218 implicating Gates and Soros and the same network in Greece can be explained by the fact that they had reliable instruments who had committed crimes for them and were all on the same page in 2022.

These instruments in the police and justice in Larisa, in the meantime, have a personal motive to silence, exterminate the reporter. In 2015, the Ebola and other epidemics and the experimental vaccines were more abstract, a mere possibility in Greece than a real threat. Everything has changed in 2021 and 2022. The Greek people saw and felt the impact of the lockdown, the shut down of schools and universities and the effects of the mass vaccination campaign. Excess deaths soared.

When people who have taken the vaccines see the injuries and deaths, or hear about them by word of mouth, and see there was no coverage in the newspapers, they think it is bizarre, sinister and conspiracy. There is a broad consensus vital information is being censored. There is growing interest in using the proofs collected in Larisa to prosecute the cartel.

The cartels' instruments especially Theodecti and the Bishop of Volos who have given the witnesses in the monastery all the COVID shots recommended by Pfizer and vd Leyen knowing they are poison must now reckon with facing the consequences of their crimes. Their crimes, also of the local lawyers Eleni Matraki and Konstantinos Christopoulos have cost the local community so many lives, also among young people as the probe is well known and has been seen. Soros and Gates were caught in 2015 and then Kremlin based journalists and Donald Trump in 2017.

While the jury was out about its significance as long as there was no epidemic medical martial law and mass vaccination programme, it has passed its verdict now.

There is a clear and growing majority opinion in Larisa, and I am sure elsewhere in Greece, and Europe that these covid vaccines have been sold as safe and effective when they were neither, that the harms they have caused are considerable and that corporations and corrupt politicians have seen this as a business opportunity for them at the expense of the public health.

The danger to reporters and the free media by a climate of impunity created when the holders of the highest political office commit the crimes was the point of my letter to ECP Juncker.

That the same crime that had been committed in Austria in 2010 against me for my accurate warnings about the experimental swine flu shot was being repeated by the same network for the same motive in Greece in 2015. It was only possible because a criminal network in the government was able to thwart a police inquiry into their crimes.

The 2010 crime was clearly commissioned then by then Austrian Chancellor Werner Faymann and the instrument was a scientist and government advisor.

When the police charged the scientist, Professor Lukas Kenner, the probe was suppressed, hidden by the Vienna prosecutors. I was refused all access to the charges or file in violation of my rights.

This continued until late 2015 when I was in Greece and able to obtain access only to be informed that the case was closed on the very day I left Austria. Faymann had ensured that the crimes he commissioned would not be prosecuted to allow a repeat.

The Greek probe D 15 218 even captured proof that it was Faymann again who commissioned the crime against me in Greece in February 2015 as described in the prosecutor report January 2016.

The proof came in the form of a spelling mistake that then newly elected Prime Minister Alexis Tsipras made of the spelling of Faymann after he visited him in February 2015 in Vienna.

Caught red handed, the cartel then targetted my evidence as I posted it my blog of their crimes end January. After Larisa police failed to bully me into taking it down, a front man, a lawyer Simos Samaras was used to file civil charges about the evidence of the massive corruption of the justice officials to hide the proofs against Soros, Gates, Faymann and Tsipras.

But it was not until September 2021, that th ecriminal cartel had the political strength in the form of von der Leyen to sentence me to one and a half years in prison for these posts in violation of every fair trial guarantee.

She knew, or should have known, and was reckless in not knowing, that the reporter revealing the negative impact of the defective vaccine product had nearly been snatched, triggering the criminal probe in 2015 because it was referenced by ECP Junker and in EC records she was obliged to review.

Knowing he had been caught removing key paragraphs from the Scribd uploads, and knowing that Attorney Generals and other law enforcement would pay attention, Gates came to Greece, I allege, to plan and deliberate with Bourla how to effect my murder to silence me once and for all and knowing they could rely on ECP vd Leyen and Mitsotakis.

They continued to plot their murder attempt and attacks because they believe they can get away it.

They had von der Leyen in power as the ECP. She had become an active participant in the criminal plot to and to silence, harass, slander and imprison and murder a reporter myself.

And so the same network came together end May 2022, beginning of June to plan their new crime.

Bill Gates came to Greece on May 27th 2022 amid reports that US state Attorney Generals were considering criminal charges over the covid gain of function research funded in part by NGO Ecohealth funded by Gates.

Media reported he met Bourla, the same Bourla who had negotiated the Pfizer contracts with von der Leyen.

To comply with the empty forms of an emergency psychiatrisation two witness statements are needed, including one about suicidal tendencies, and the signature of a prosecutor.

They had these already as they knew from the probe D 15 218 because they had organized the original statements in 2015. They activated their local network in Greece.

On June 24<sup>th</sup> 2022, former MEP Stanley Johnson, the father of then PM Boris Johnson, met key culprit in the original crime in April 2015, the Bishop of Volos on Mt Pelion, close to Larisa. He attended a ceremony in Argalasti giving him honorary citizenship.

He has a holiday home there.

Present too was the Minister of Interior, the director of Thessaly police chief Asterios Manzokas, who had helped bury all the police reports and proofs against Gates and Soros and replace them with the statements and false accusations of the culprits in 2015, citing my reports about the risks of the Ebola vaccine as proof that I was mentally ill and falsely claiming I was suicidal.

Boris Johnson went to the same school in Brussels as vd Leyen, whose father worked for the EU.

Boris Johnson and the British government, which includes the monarch, and King Charles knew that the invitation of Dr Sarah Wollaston then Chair of the Health Committee of the UK Parliament to me in 2016 to testify on whether the UK was prepared for an epidemic, as referenced by Michael

Hubel, implicated them. They had ignored warnings. They had manufactured the covid crisis through failed policies.

The Bishop of Volos is in charge of the monastery of St John the Forerunner, the scene of the original crime in 2015. It was the statements of the culprits, Theodekti, Theoniki and Garyfalya which were used again in 2022, lifted directly from the corrupted file from 2015.

This I learned from the police at Larisa who falsely imprisoned me from a nurse and others. I was told that I was a repeat offender and had made the same allegations about vaccines in 2015.

It is clear V d Leyen has a network in Greece. She has "dear Albert" as she called the Pfizer CEO Albert Bourla, whose home town is Thessaloniki. She has a supporter in Greek PM Mitsotakis who gave 32 million euros in grants to her husband's company, Orgogenesis, in 2021.

She has Eva Kaili, the Greek MEP and VP of the European Parliament who as Chair of the Science and Technology Panel green lighted the use of mRNA technology and nano lipids for covid vaccines which she promoted. Kaili has been arrested for taking cash to help promote the message that Qatar wanted and get political favours ahead of the World Cup. She and her father, Alexandros, and partner, Francesco Giorgi, were caught with 1.5 millions euros in cash.

In the light of this corruption scandal, it is legitimate to ask if Kaili sold other favours for cash, if Bourla or other pharma executives bought her backing of the mRNA vaccines, so crucial at the EU Parliaments committee stage?

With their political base in Thessaloniki, Eva and Alexandros Kaili have and had the right network to effect my false imprisonment there.

Crucially, her father Alexandros's was appointed in May 2014 to the board of the hospital Papageorgiou close to Papanikolau whose former staff include key actor Diamantis Chloros, a doctor heavily funded by Pfizer, AZ and Novartis.

In 2012, he was treasurer for annual Panhellenic Congress of Thoracic Disease has been established as the biggest scientific event held in Greece for pneumonologists, thoracic surgeons and paediatric pneumonologists, which took place in November 2012 in Thessaloniki, Greece.

Many of the doctors and nurses who attended are from Papageorgiou and Papanikolaou hospital attended.

At the end of the programme, there is a list of pharmaceutical companies who made the event possible.

“Boehringer Ingelheim HELLAS S.A. Roche Hellas S.A. ELPEN A.E. Pharmaceutical Industry NOVARTIS HELLAS AstraZeneca TAKEDA HELLAS S.A. GlaxoSmithkline Hellas Abbott Laboratories Hellas CHIESI HELLAS SJA PHARM LTD UCB S.A. VIANEX AE Pfizer Oncology SPECIFAR TEVA HELLAS S.A”

So there are personal and or professional connections between Alexandros Kaili and Chloros, making the Kaili family the ideal intermediary for any favours von der Leyen may have wished, although any guilt and its precise degree can only be established by an investigation.

Chloro as treasurer may have personal direct links to Pfizer, Novartis and other sponsors of the Thoracic society s conference. He would be in an ideal position to take bribes and distribute them to a network in the hospitals.

Marina Arvaniti, the psychiatrist who signed my confinement order in 15 minutes, knowing the co signer Dr Nondas Vasilikos was not present and had never met me

According to emergency laws, two psychiatrists are supposed to conduct an independent examination. Rather, one of them had signed the confinement order in advance and the other signed it in ten minutes. Arvaniti said her decisions were based solely on psychiatric criteria, but she knew that it was false. I showed her my invitation from Dr Sarah Wollaston and other evidence I was a science reporter on my laptop.

She read or feigned to read a sentence from my blog on her smart phone and declared what I wrote about vaccines showed that I was mentally ill, repeating the talking points of Theodekti in 2015 as well as Gates and Bourla.

She feigned to not recognize the probe showing the very same statements had led to the opening of a probe by the Greek police, D 15 218, which had collected evidence against Gates and Soros, and a similar attempt in Austria in 2010 to misuse emergency pyschiatrisation laws to disappear and murder a reporter had also triggered a police probe against the culprit Lukas Kenner.

Reporter and the media gong about their business should and do enjoy especial protection under laws.

She went about her business, feigning not to understand that the process had been irregular, that I did not need drugs for schinzophrenia and that the drugs administered to me by force, Zyprexa, were harmfultome.

It is not clear if she is related to Kleio Arvaniti who works in Thessaloniki for Pfizer.

The false imprisonment took place in a hospital which is only about 5 kilometres from Pfizer s digital hub at 2 Tompazi St Thessaloniki T.K. 55535.

Thessaloniki is also the hometown of Albert Bourla.

The Papanikolau hospital is located in a remote place surrounded by woods and at the top of a steep incline above Thessaloniki, the home town of Bourla and the location of Pfizer s HQ. I was nearly murdered in a ward run by a doctor who is on record as receiving funds from Pfizer as the treasurer of a society in 2012. That, using the very same statements from 2015 cherry picked from the corrupted probe.

The journey from the Papanikolau hospital in Exozee to Thessaloniki requires a detour via the Papageorgious hospital.

In 30<sup>th</sup> January 2022, I sent an email to Albert Bourla with copies of all the proofs collected against Gates and Soros concerning the use of Molnupiravir s covid drug.

Showing wilful blindness, Bourla never replied. And in just four months, Bourla would meet Gates in Greece to plan the next murder attempt with the help of vd Leyen and Mitsotakis.

Within the EC records was a letter from ECP Juncker referencing this very crime as well as an email from top official Michael Hubel referencing the violations to cover up the proofs against Bill Gates and Soros by. among others, police chief Asterios Manzokas.

The issue I raised was the high level of impunity for deadly attacks against a reporter as an indicator of a corrupted criminal justice system.

It is also red flag when a reporter is being targeted. It is a sign someone wants to hide something, a crime.

The PACE inquiry in 2010 identified the influence of pharma on decision making as and stated it must never be allowed to happen again.

But it did happen under von der Leyen, and she knew that the free media was a threat to her too.

She knew the very actions she was engaging in had been condemned by an inquiry into the swine flu vaccine scandal in 2010.

She has a strong motive to join the scheme to murder the reporter.

She has a motive to use her position to create a climate of immunity with her collaborators Mitsotakis, Gates and Bourla. She has a motive to corrupt the justice system preventing it from investigating their crimes against reporter, and these corrupt justice officials are crucial to her scheme. They would not and could not commit illegal acts without political cover guaranteeing their immunity.

Ron DeSantis has announced a grand jury to investigate the wrongdoing of mRNA vaccines in Florida.

Florida has the death penalty.

A key piece of evidence in D 15 218 showing the personal knowledge of Bill Gates and George Soros is a report in Florida's Tampa Bay Times.

These proofs are widely known not just by ECP Juncker.

Gates, Soros and vd Leyen know they could face legal action in the USA for their crimes. Orgenesis is based in the USA.

Without vd Leyen's willingness to sanction, approve and hold her protective hand over these massive crimes involving government officials, the corruption of the justice officials and police would not have been possible. The murder attempt in June 2022 would not have been possible.

Her problem is that she cannot justify her silence, omission and inaction.

She cannot justify why she has chosen such a radically different position to ECP Juncker, why she not sent a letter like him offering support in precisely this same probe especially after the actual murder attempt in June 2022 nearly succeeded.

It is clear she chose deliberately to create a climate of impunity in order to enable her collaborators to carry out the crime with the determination they succeed and silence, exterminate a reporter exposing their crimes and corruption in 2022.

## Von der Leyen s violations of code of conduct. What the EC records reveal

ECP vd Leyen failed to fulfill her explicit statutory duty to remain independent and review documents and EC records. Embroiled in conflicts of interest through her husband s, she was determined to fraudulently maintain their authorization in order to continue to sell covid jabs and increase sales and profits.

As ECP von der Leyen is obliged to follow a code of conduct which includes declaring conflicts of interest and reviewing EC records on policies, exercising the precautionary principle and being independent of all outside influence. The aim of these codes is to ensure the ECP acts in the interest of the EU.

The EC s code on the conduct of commissioner is contained in “RULES OF PROFESSIONAL ETHICS AT THE EUROPEAN COMMISSION LEVEL”

The Rules of Professional Ethics for Members and Staff of the European Commission are governed by the following texts:

- I. The EC Treaty (in particular Article 213 and 287)
- II. The Code of Conduct for Commissioners (in particular Independence and Dignity and Declaration of Financial Interests)
- III. The staff regulations (in particular Article 11 through to 18)

#### IV. The Code of Good Administrative Behaviour (in particular objectivity and impartiality)

These texts apply to members of the EC staff (in particular Article 11 through to 18).

Article 11 (96) states “An official shall carry out his duties and conduct himself solely with the interest of the Communities in mind; he shall neither seek nor take instructions from any government, authority, organization or person outside his institution. He shall carry out the duties assigned

to him objectively, impartially and in keeping with the duty of loyalty to the Communities.”

Article 11a (96) states “1. An official shall not, in the performance of his duties and save as hereinafter provided, deal with a matter in which directly or indirectly, he has a personal interest such as to impair his independence, and, in particular, family and financial interests.”

When we look at the records and information in the possession of ECP vdLeyen when she assumed office and was confronted with the covid emergency, we can have no doubt, she knew or should have known about a debate about the swine flu vaccine scandal of 2009, referenced by ECP Juncker, which resulted in an inquiry in 2010 by PACE. This criticised unjustified scares and fears, the influence of pharmaceutical companies and a lack of transparency and accountability.

The covid is a suspicious event which she should have identified as such. She should have realized it was another "unjustified scare". The death rate of covid is the same as the seasonal flu at 0.096% according to PHE. There was not a single death in Europe from covid when she began to roll out the lockdowns and mRNA vaccines.

She knew there was no emergency. But she feigned and dissembled that there was one to justify spending billions on unnecessary vaccines for the profit of her family.

She knew or should have known that this special class of vaccine issued under emergency authorization is especially risky. But she ignored the warnings to increase sales.

Although required by EC rules to reveal declaration of financial interests also of her spouses, she failed to do.

This despite the fact she knew or should have known the failure to declare conflicts of interests was a key criticism of the 2010 inquiry. A key recommendation, the PACE inquiry made was to ensure transparency. Disregarding almost all the recommendations of that inquiry, ECP vd Leyen acted as a secret arm of the pharmaceutical companies giving them a significant advantage as she used her office for the centralized procurement of vaccines, to oversee a laxer approval process at

the EMA, clinical trials, indemnity clauses and the marketing campaign to increase sales aggressively, and to silence, imprison, attempt to murder a reporter exposing their crimes. From the beginning, Vd Leyen has sought to evade rules and statutes designed to protect the public from corruption. She knew that she was violating EC rules on conflicts of interest and independence but she was determined to advance a scheme to make money for her self and her family members and partners.

This broad failure of ECP vdLeyen to fulfil her explicit statutory duties to review EC documents in order to understand the facts, the evidence and shape the best policies makes her guilty by omission, default or commission.

The documents are stored, organized and made accessible for reference information and can be retrieved any time.

Requested repeatedly to produce her copies of these records, vd Leyen and her collaborators in the DGS have refused.

An application made through the official portal to access documents, EASE, on November 10 2022 registered with the Request No.: 2022/6509 has still failed to produce them.

These records prove her knowledge, her deliberate determination to join in the false and deceptive marketing plan.

I quote my reply in full here because it summarizes key legal points about proving vd Leyens guilt either through commission or omission.

In reply to the DGS officials asking for more time to deal with my request I ask why when it is a simple administrative request?

"You mention the need for " internal consultation and thorough analysis" of my request

May I also, therefore, ask for any records, minutes, communications or any documents related to your " internal consultation and thorough analysis" of my request as you describe it?

As a review of my request (attached) shows, I am asking you primarily for your copies of EC documents in my possession, copies of which I have sent you. It should surely have been a very simple, routine administrative matter to send me the copies of the EC documents I sent you within 15 days.

An analysis of the communications and their significance is not your task.

Whether any of these communications reveals that ECP Ursula von der Leyen has knowingly departed radically from the policies of her predecessor ECP Juncker without justification and has knowingly been orchestrating a massive, fraud, diverting billions of euros of European tax payers money to mRNA covid vaccines she knew or should have known to be unnecessary, defective and harmful and for her own personal benefit, while concealing her conflicts of interest, and to help grow her husband s mRNA company, Orgenesis, and generate a windfall for her collaborators in pharmaceutical companies, Pfizer, PR company McKinsey as well as Billionaire collaborator Bill Gates with reckless disregard for public health, is surely a matter for prosecutors to consider.

And whether any of these communications also reveals Ursula von der Leyen has knowingly joined in a scheme, a design, a plan to commit first degree premeditated murder in April 2015 against me while I was exercising my function as a reporter as recognized by a letter of Jean Claude Juncker to me in December 2015 triggering a Greek prosecutor probe, which by the end of September 2015, found the masterminds behind the crime to be Bill Gates and George Soros, and whether Ursula von der Leyen has refused to me support like ECP Juncker in protecting my rights against violations to hide these proofs against Gates in order to create a climate of impunity to enable the very crime by the very same culprits to be repeated in June 2022 as well as other crimes and, this, in order to hide her own and her collaborators fraud and harms is also a matter for prosecutors and the public to decide, I would suggest.

The delay in sending me copies does rather somewhat give the impression you are trying to hide

EC records, which also just so happen to implicate Ursula von der Leyen in knowingly committing serious crimes.

I am sure this is not the case. I am sure you perform your duties according to the EC rules which require independence, professionalism and resistance to political influence in matters of corruption.

But since " internal consultation and thorough analysis" of my request have taken place, may I please see copies of all these deliberations too? This, to form any idea of your decision making process particularly if there are any communications from Ursula von der Leyen and or her cabinet members or any other MEPs or officials outside EASE concerning whether you should release them or not.

Most helpful would be if you could send any documents showing whether ECP von der Leyen reviewed these records or not, when and where and with whom. And if she did review them, what her deliberations were, and what reasons she gave for ignoring, sidelining, downplaying the information contained within them collected by her predecessor and EC health officials of the highest level. For we can infer she did, indeed, decide to ignore them from her actions, omissions as well as from her radically different policies concerning, on the one hand, epidemic vaccines, on the one hand, and, on the other hand, protection of the media freedom, specifically my right to life, a fair trial, as well as the right of the public to informed consent about the risks of the vaccines she has been promoting.

Please find key communications attached again so you can find the documents I requested more easily," I wrote.

These records do not identify just one fact, one data point. They identify a debate, a conversation about what are the best policies, and hundreds of data points, facts, proofs which show the dominant narrative to be based on false claims similar to the ones made against the manufacturers, distributors and marketers of opioids in the USA, which resulted in their trial.

The challenge for policymakers in the EC and the other decision making bodies of the EU was then, and is now, to decide which of the two competing narrative was correct, which version was accurate and true. For a broad consensus must emerge between the EC and CoE and European Parliament about what policies to pursue. Two entirely different and contradictory sets of policies flow from the two competing narratives.

The dominant narrative promoted WHO, Bill Gates, and pharma corporations clear policy recommendations. The first and main recommendation was to contain the outbreak using experimental vaccines. These were to be rolled out at the earliest possible opportunity. They were the solution of what we can call "pharmaceutical industry policies" because they clearly favored the

increase of sales and profits of the pharma industry.

I, along with others, presented the facts, studies and data challenging that narrative, showing the experimental Ebola vaccines caused Ebola and so would cause and fuel an Ebola outbreak.

My recommendations included accurate tests, and standard epidemic control measures. That is why I focused on correcting obvious flaws in these measures as used by WHO,MSF and others.

When we look at the actual policies pursued by ECP Juncker and his team, and the broad institutions of the EU, during multiple Ebola outbreaks in Africa, which threatened Europe, we can see that they are consistent with my recommendations and so with the facts as they could be established by research.

Pharmaceutical policy, policies which resulted in huge profits for pharma, were kept separate from EC public health policy making.

The profiteer of the ECP Juncker s policies were the EU tax payer. The Ebola threat was contained with minimal cost and disruption.

ECP Juncker and his team not only did not roll out Merck's Ebola vaccine in Europe. They did not give it a license.

All that changed with von der Leyen.

ECP von der Leyen must explain why she chose to make such a radical departure from ECP Juncker s policies and on what basis.

Policy makers are required to be able to justify shifts on policy.

Why did she chose to give Merck's Ebola vaccine a license end 2019 departing from policy of her predecessor, for example, despite the warnings in EC records?

Why is she giving millions to a dangerous and uncontrolled experiment with these vaccines in Uganda?

To hide the fact that there has been a debate about the best policies for handling vaccines and the safety and effectiveness of the Ebola vaccines, vd Leyen has sought to hide these records.

The reason why ECP vdLeyen and her collaborators at the DGS not appear to want to release her copies of these records is because she knew that they prove her knowledge that she has conspired deliberately with pharamaceutical companies to carry out the swine flu plot thwarted in 2009. This for the profit of her family members.

Presented with these records, the ECA emailed me to suggest a criminal inquiry was warranted but they were not the body to undertake it as I mentioned.

Soon afterwards the EPPO, the EU prosecutors, announced an investigation into the EU's covid vaccine contracts.

Her husband, Heiko, hastily gave him his position of the board of an mRNA consortium funded by the EC when media focussed on how his company, Orgenesis, had directly received money from it.

Albert Bourla refused twice to testify to the covid committee of the European Parliament.

In addition, the EC records also show that vd Leyen knew or should have known about a prosecutor probes related to murder attempts against a reporter for exposing the swine flu vaccine improper marketing scheme in 2009 and the Ebola vaccine scheme in 2014, 2015.

She should have known that there was a debate about the need to protect the free media from reprisals in EC records.

She should have known ECP Juncker took the threat seriously. He had even suggested an organization, the ECPMF, as a potential source of help and funds to me in his letter in 2015.

When I asked them in a genuinely dire emergency situation for help in October 2022, they did not reply.

When I asked vd Leyen to support my application for emergency funds, she did not reply.

Denied a fair trial and a speedy trial, subjected to massive violations of due process since 2015, my funds robbed by the culprits, it is inevitable that my financial situation should become dire.

The EC records, moreover, prove that the EC has had strong, vital evidence about the identities of key actors behind this plot, namely Bill Gates and George Soros.

The reason why she offered no support to the reporter, myself, is because she had joined in the plot as discussed above. She had hidden her conflicts of interests. I asked her about her declaration in an email on 28<sup>th</sup> November 2022.

She did not reply and I found a copy on the EC website the next day and posted it up, showing she had made misleading statements about conflicts interests to suggest she had none when she knew her husband's company Orgenesis was directly profiting from them.

Her determination to silence a reporter became most clear when I posted the reports about her failure to disclose conflicts of interest, the revenue growth of Orgenesis and the role of McKinsey in placing her in office at the end of November.

When this reporter asked her about her declaration of interest in November 2022, she did not reply. When I found it and posted a copy on her blog showing she had concealed conflicts, her motivation to attack the reporter increased.

On December 2, 2022, vd Leyen came to Athens apparently to carry out the plan to imprison me, snatch and silence me once and for all.

Coordinating with her son's company, Google, Blogger, my fourthempire blog spot blog was removed on December 4<sup>th</sup> 2022. Whether David v d Leyen played a role is a matter for investigation. But he has a strong motive to seek to censor information about the conflicts of interests and corruption of his mother.

I alerted others in an email on December 5<sup>th</sup> 2022.

That same day a lawyer in Larisa signed a letter which would serve as a fake eviction notice.

The connection to the cartel is clear.

It is proven also by the fact that this legal action was dated July 15<sup>th</sup> 2022 when I was in Exozee.

The cartel's front men in Larisa, the landlords, Maria Tzintzirouli and her family, felt free to make absurd and incredible claims about the rent because they knew I was in Exozee and never expected me to get out and see them and be able to show how absurd they were.

They allege I had not paid rent since early 2018. Yet they cannot explain why it was only five years later that they decided to file legal action against me and in the middle of summer just when my fate seemed sealed in Exozee, apparently ensuring them success in any legal action against me as I was not there to contest their lies.

The ruling that I owed the rent came immediately after I gave a copy of the ECA's email to Larisa prosecutors on October 4<sup>th</sup>, and can be seen as a reprisal. But though the ruling found me guilty, it did not order my eviction.

I folded my appeal into the submission to the 27<sup>th</sup> October EPPO which I sent to the Supreme Court in Greece and Larisa court.

In a dire financial situation, I requested emergency help from the organization recommended to me by ECP Juncker in 2015.

They did not reply.

The fact that three attempts were made in two days and using ever more rogue means shows again the determination of vd Leyen to silence a reporter exposing her profiteering from the covid vaccine crisis.

Coordinating with her son's company, Google, Blogger, to try to keep their crime secret, my fourth empire blog was removed just before on December 4<sup>th</sup>. To warn people, I used my email.

A quick review of the events

On 2<sup>nd</sup> December 2022 Athens vd Leyen came to Athens to meet Mitsotakis.

The lawyer signed the fake eviction notice on the basis of the legal action started when I was in Exozee.

On 4<sup>th</sup> December 2022, my blog was removed by Google, Blogger allegedly for violating community rules.

On 5<sup>th</sup> December I sent an email pointing out my blog had been removed just when I was reporting on vd Leyen's conflicts, conflicts of interest, Organogenesis and McKinsey.

On 6<sup>th</sup> December 2022 first attempt at illegal eviction was made and failed when the two women who came with a locksmith could not produce a valid court order.

They returned with two police who threatened to arrest me on the spot but the eviction again failed when they could not produce a valid court order or so called Klitera order for the police and the police left telling them to do so.

On 7<sup>th</sup> December 2022, this crime gang resorted to sending the very police woman implicated in the Exozee imprisonment, who did not care they could not produce either a valid court order or a valid order to change the locks. They did not care there was no contract and so no receipts could be asked for. They did not care about the obvious proofs of lies. They did not care there was no legal basis to their actions. They had only one objective. To make sure I was locked out illegally from my flat and all my possessions, including mobile phone, computer, proofs and books could be seized while I was snatched again and imprisoned.

Another email on 9<sup>th</sup> December 2022 highlights the cause and effect between my reports and the crimes against me.

None of these crimes carried out by rogue Greek officials would have been possible without Mitsotakis and von der Leyen. They are politically motivated crimes.

If she had shown me the same support as ECP Juncker, it would have stopped the crimes in their tracks. The police are Greek government officials.

But she is determined to misuse her office to eliminate whistlers of her own crimes. And she has an ally in Mitsotakis and Bourla and other collaborators, specifically Gates and Bourla, who fear arrest.

In an email on 10th December 2022, I point all the proofs allow for the immediate arrest of v d Leyen and her collaborators for first degree premeditated murder attempts.

This broad failure of ECP vdLeyen to fulfil her explicit statutory duties to review documents in

order to understand the facts, the evidence and shape the best policies has continued for two years.

The documents are stored, organized and made accessible for reference information and can be retrieved any time.

Despite the growing evidence of deaths and injuries, recorded on OpenVaers also, she has failed to discover a problem, failed to retrieve the documents in her possession, failed to take any corrective action.

She should have checked to see whether the vaccines were causing deaths and injuries and whether the data collection was being deliberately structured to evade scrutiny

ECP vd Leyen could change her policies at any time as the events unfolded.

She has not.

She has shown willful blindness to the growing evidence of deaths and injuries.

She and her collaborators in McKinsey and Pfizer must now fear legal consequences.

On December 9<sup>th</sup> 2022, Belgian police raided the EU Parliament and 20 homes in Brussels and arrested a key ally of vd Leyen, Greek MEP Eva Kaili for corruption and five others.

On 13<sup>th</sup> December, French police raided the party headquarters of Macron in Paris as well as McKinsey s office.

Crucially, that same day, the nightmare of the criminal cartel came true.

Governor Ron De Santis announced a grand jury to investigate the wrong doing of the mRNA manufacturers.

## Conclusion

Vd Leyen is a wolf in sheep s clothing. As long as vd Leyen is permitted to misuse her office to deceive and mislead European consumers about the risks of these mRNA vaccines, these consumers are easy prey.

Faced with the corruption scandal of Greek MEP Eva Kaili, her ally enjoying also the support of Mitsotakis, vd Leyen suggested an ethics body.

European consumers don t need an ethics body. They need to see von der Leyen in prison along

with her collaborators for luring them to take a very risky genetic injection using false and deceptive claims for profit in what may be the biggest corruption scandal in the history of Europe as well as the biggest public health disaster.

Characteristic of vd Leyen is her lack of repentance or remorse.

Faced with the arrest of Eva Kaili, von der Leyen continues to feign and dissemble she is an independent servant of the European public. She knows she is not. She knows of the mounting proofs of her corruption in relation to the covid vaccine contracts have now reached the threshold for her prosecution for corruption, organized crime and false and deceptive marketing at a far more serious level than Kaili.

Asked whether vd Leyen could see a problem with corruption in the EC, she claimed there was transparency knowing there was not.

She feigned and dissembled she would take consequences and "act accordingly" if she found corruption inside her department when she knows she has no intention of penalizing herself in any way or resigning for her corruption.

"On whether the European Commission is analyzing the infiltration of the plot in the institution itself, the German conservative has defended the transparency record of meetings of members of the European Executive and said that it is analyzing it, ensuring that it will act accordingly if there is any development that affects the institution."

Her actions she is not concerned about ethics or serious investigation into corruption, especially not of herself and her connections with McKinsey, Orgenesis, Pfizer, Bill Gates. If this were true, she she were to take the consequences of corruption at the EC, she would resign. Tellingly at the press conference she continued her false claims.

Omitting all mention of the report of the ECA criticising her shady vaccine deals, she has stated she is concerned about ethics, misleading the European public.

She omitted all mention that the European Prosecutors office, EPPO, has opened an investigation into EU s covid vaccine contracts which focus on her in transparent contracts.

She omitted to mention she refused to provide the ombudsman with her deleted SMS messages with Albert Bourla to negotiate Pfizer contracts.

She made no comment on the fact that Albert Bourla has twice refused to answer questions to the European parliament.

She omitted to mention Bourla had been rapped for false and misleading claims by the UK Pharma watchdog for false and misleading claims. All this to mislead the European consumer and persuade them there was no corruption involved in the procurement of the covid vaccines.

She omitted to mention that Pfizer executive Janine Small admitted the vaccines had not been tested for transmission and so were a priori defective for using in controlling an epidemic.

She also omitted to mention the criminal probes in Greece implicating her in trying to murder, silence and destroy a science reporter exposing her false claim.

She omitted to mention her son s company, Google, Blogger, had removed my fourth empire blog as I was reporting on her corruption on December 4<sup>th</sup> 2022 and that she her self had actively participated in new, brutal assaults on the reporter.

Vd Leyen her collaborators have no intention of ending the climate of immunity they have created by corrupting justice officials. They have no intention of policing themselves.

They also have no intention of acknowledging the harms of the covid vaccines and stopping the campaign despite the mounting death toll.

Far from it,they are determined to censor, murder and silence a reporter who tries to inform the public and protect public health.

As the Greek prosecutor probes clearly show she is acting in concert with Bill Gates and George Soros, I ask for their immediate arrest too.

Another collaborator who has emerged from the shadow is Albert Bourla, I ask for his immediate arrest to.

To sum up. The criminal cartel of vd Leyen continues to threaten my life. She can take action to correct the massive violations of due process,end the climate of impunity, ensure my stolen money is returned and I get compensation for the violations of my fair trial guarantees and right to speedy justice. She can use her office to send me a letter of support like ECP Juncker. She can organize funds for me. She has an obligation to do all this. A free media, an open debate about policies, is in the best interest of the public.

She refuses to offer me political support because she has joined the criminal cartel identified in EC records. She has decided to misuse her office to join in the crimes against this reporter. She shows no remorse. Neither do her collaborators.

In particular, vd Leyen wants to hide evidence of her wrong doing, the EC records showing the

scale of her misconduct, the research exposing her crimes as legal action starts and trials loom for her and her collaborators. She is ready to kill reporter in cold blood using whatever means she can as ECP, which includes, influence over the Greek police and justice officials.

She has been caught in the act of organizing illegal attempts at my imprisonment in December 2022 to target specifically the proofs of corruption on my fourthempire blog. While I escaped her attempts at false imprisonment, I am now left homeless in the middle of foreign country, without my phone, seized by the cartel among my other things in the flat, and perhaps to be used as part of an attempt to roll out a “Trojan Horse” style digital fake me or other fake double to withdraw and sabotage the proofs against them from within, as well as a computer, all my possessions in the flat, including the proofs with very limited financial means. This, while exposed to ever new false accusations, attempts to arrest me or disappear me by the cartel. Her actions and inactions and omission pose a direct and serious and immediate threat to my life and to the free media. V d Leyen intends for me to be unable to continue to expose her corruption either by false imprisonment, starvation or other means.

She has been caught in the act misusing her office to engage in crimes to silence a reporter also for holding EC records revealing her misconduct.

The fact that she has been caught in the act justifies the lifting of her immunity and her immediate.

Attacks against a reporter are attacks against everyone.

The fact that she has been caught in the act attempting repeatedly to murder a reporter together with her collaborators, and has shown a premeditated, determined scheme to silence me in December for reporting on her conflicts of interest at the end of November using rogue police in Greece, justifies her being held in custody.

To conclude. A supply all the proofs needed to arrest ursula von der Leyen immediately for being caught in the act of trying to murder a reporter, myself, for exposing her corruption.
